City of Omaha Requirements for Specific Dog Breeds

If you own a "Pit Bull," you will be required to properly leash and muzzle your dog whenever they are outside, unless they are in a securely fenced yard. The dog must also be accompanied by a person 19 years of age or older when outside of your home.

The City of Omaha has included the following breeds in the "Pit Bull" category:

- American Pit Bull Terrier
- Pit Bull
- American Bulldog
- Staffordshire Terrier
- Dogo Argentino
- Presa Canario
- Cane Corso

If you own one or more dogs in this group, you must also comply with the following requirement to complete licensing:

- Provide proof of current personal liability insurance of \$100,000 or more. This can be found in your homeowner's or renter's insurance. We need a current copy sent in with your paperwork each year to confirm the information is still correct and not expired (copies will not be returned to you)

PLEASE READ CAREFULLY

YOU ARE REQUIRED BY LAW TO LICENSE YOUR PETS. Failure to do so is a violation of City ordinances 6.26 and 6.103 and carries a penalty of a fine up to \$500 and/or jail sentence up to 6 months per pet.

LICENCE RENEWALS ARE DUE JANUARY 1ST EACH CALENDAR YEAR AND ARE DELINQUENT AFTER MARCH 15TH.

March 15th - March 31st: License fees are doubled
March 31st – December 31st: \$50 per pet (\$100 max)

The City of Omaha requires proof of rabies vaccination. Proof of sterilization is required if you license at the altered rate.

Check Processing Policy

By sending your check, please be aware that you are authorizing the Nebraska Humane Society to use the information on your check to make a one-time electronic debit from your account as a financial institution indicated on your check.

This electronic debit will be for the amount of your check; no additional amount will be added. [If we cannot collect your electronic payment, we will issue a draft against your account.]
