Senior Discounted Rate

Residents that are 65+ qualify for free licensing for altered (spayed/neutered) pets only, and do not need to pay the \$5.00 processing fee.

For unaltered pets, you will be charged the licensing fees, but still no processing fee. If you license online, you will be charged the processing fee.

Please submit proof of age (state ID, passport, etc.) to license at the senior rate. Once we have proof of age on file, you do not need to resubmit ID.

For future licensing, you will still need to submit your statement to license and confirm that the information on file is current.

Check Processing Policy

By sending your check, please be aware that you are authorizing the Nebraska Humane Society to use the information on your check to make a one-time electronic debit from your account at the financial institution indicated on your check.

This electronic debit will be for the amount of your check; no additional amount will be added. If we cannot collect your electronic payment, we will issue a draft against your account.
